To apply for the Education Innovation Awards, your innovation must meet five broad criteria:

1. Registered as a nonprofit, NGO or charity.
2. At pilot stage with 200+ beneficiaries and 18+ months' existence and initial evidence of scaleup potential.
3. Working in, or planning to scale up to, one or more of these countries: Greece, Kenya, Lebanon, Nigeria, Tanzania, Turkey, or Uganda.
4. Focused on an issue under one or more of Theirworld's three pillars (see website for definitions).
5. Reaching marginalised learners, such as people in poverty and/or refugee or displaced populations.

**Even if you don't yet meet all the above criteria, we encourage you to complete the form so we can stay in touch when other opportunities arrive.**

## Questions – Eligibility

Theirworld's Education Innovation Awards 2021 offers a two-week scale-up bootcamp for **10 finalists**. You will be supported to make your innovation scale-ready through a series of workshops aimed at building your skill set and generating evidence.

After the bootcamp **5 winners** will also receive:

1. A grant of £50,000 to be spent on scaling up your innovation
2. An exclusive four-month accelerator to build your team, and generate evidence to grow your innovation.
3. Mentoring from experts on scaling, education and monitoring and evaluation.
